<b>Statement of Issue:</b>	<p>The College of Education wishes to terminate the following inactive graduate programs in order to remove them from the Maryland Higher Education Commission Academic Program Inventory. These programs have no enrolled students or applicants.</p> <p>The programs proposed for termination are as follows:</p> <ol style="list-style-type: none"> <li>1. The Ph.D. and Masters programs in Curriculum and Instruction: Early Childhood Education Area of Concentration</li> <li>2. The Ph.D. and Masters programs in Special Education: Education of the Gifted and Talented Area of Concentration</li> <li>3. The Masters program in Special Education: Educational Diagnosis and Prescription Area of Concentration</li> <li>4. The Masters program in Special Education: Integrated Special Education Area of Concentration.</li> </ol> <p>The proposal was submitted to the Senate by the Office of Academic Affairs following favorable recommendation by the Academic Planning Advisory Committee (APAC) on January 25; the Graduate Council Programs, Curricula &amp; Courses Committee on January 28 (with email notification to the full Graduate Council); and the Senate Programs, Curricula &amp; Courses</p>

	Committee on January 29.
<b>Relevant Policy # &amp; URL:</b>	N/A
<b>Recommendation:</b>	The Senate Committee on Programs, Curricula, and Courses recommends that the Senate approve these program terminations.
<b>Committee Work:</b>	The Committee considered the proposal at its meeting on January 29, 2010. Stephen Koziol, Associate Dean for Academic Programs, Outreach, and International Initiatives, was present to answer questions. After discussion, the Committee voted unanimously to recommend the proposal.
<b>Alternatives:</b>	The Senate could decline to approve the proposed program terminations.
<b>Risks:</b>	If the Senate does not approve the proposed program terminations, the University will continue to have these unused academic programs listed on the state's academic program inventory.
