ISSUE

Lee Friedman, Senior Lecturer

I have been at the University of Maryland in the Department of Chemistry and Biochemistry since 2007. During this time, I have been a member of the Senate Student Conduct Committee, Campus Affairs and Academic Procedures and Standards. I have a solid understanding of how the Senate runs and I understand the importance of the issues that the Senate handles as well as how the construction of committee charges guides the legislative process. My relationships with stakeholders on campus reaches far outside of my Department via working with the Office of Student Conduct, various committees and working groups, and my involvement in the recent PTK symposia.

Teaching large (as large as between 600 and 700 students) and small(er) classes, I will be able to advocate for PTK faculty and provide insight into how small policy changes can affect those of us who teach and work with large numbers of students. I will also be able to guide the SEC process by providing an informed perspective that considers issues from multiple angles, and that is respectful to all members of our campus community while also being realistic and reasonable in light of current resources.

Jordan Goodman, Distinguished Univ Professor
College of Computer, Mathematical, & Natural Sciences

I have spent my entire academic life at the University of Maryland - as a student, postdoc, professor, department chair, parent, alumnus, and even Senate chair. I believe the University Senate, through its commitment to shared governance, can and should play an important role in defining the common mission of teaching and research, and leading in our quest for excellence. It is this goal that I have in seeking another term on the Senate Executive Committee.

My research is in particle astrophysics, studying high energy gamma rays and neutrinos from space. As principle investigator, I currently lead an international effort of 20 universities and 150 scientists from around the world on the HAWC Gamma Ray Observatory in the high mountains of Mexico. My research has been recognized with numerous awards including the Yodh Prize of the International Union of Pure and Applied Physics, a shared 2016 Breakthrough Prize in Fundamental Physics and being appointed a University of Maryland Distinguished University Professor.

Teaching is a passion for me. I have been recognized with numerous awards, including my selection as a Distinguished Scholar-Teacher, the USM Regents Award for Excellence in Teaching, the CMNS Board of Visitors Creative Educator Award, and the Kirwan Prize for Undergraduate Education. I feel fortunate to have been part of a supportive department and several active learning communities on the campus.

I believe strongly in contributing to the service of the University. During my seven-year term as chair of Physics, I learned a great deal about how the University works. I teamed up with campus leaders to create our Joint Quantum Institute (JQI) with NIST and brought the \$135M Physical Sciences Complex from an idea to completion. In addition, I have been engaged with the University Senate in a variety of ways. I am currently in my seventh term as a faculty senator including serving as Senate chair in 2016-17 and on the SEC this year. I played a major role in creation of the Senate Committee on University Finance on which I currently serve. Previously, I have chaired the Senate Student Affairs Committee, the Senate Research Committee, and the University Research Council. I have served on the Athletic Council, University APT Committee and have been the faculty representative on the Board of Governors for the Alumni Association for the last 30 years.

**Meredith Gore, Associate Professor
College of Behavioral & Social Sciences**

I am currently an Associate Professor in Human Dimensions of Global Environmental Change in the Department of Geographical Sciences (GEOG) and a faculty affiliate with the Advanced Research Laboratory for Intelligence and Research (ARLIS). My research is focused on environmental risk, particularly nature crime, interdisciplinary and participatory mapping, and science diplomacy. I have active research projects in 6 countries on 2 continents with expertise in Africa and Southeast Asia. I currently lead an international team of scientists from 9 universities in 3 countries on mitigating biosecurity risks from the intersectionality of illegal wildlife trade with emerging zoonotic pathogens. I taught study abroad in Madagascar for 10 years. I am a University of Maryland Presidential Research Fellow, an American Geographical Society Council Member, a National Academies of Sciences Jefferson Science Fellow, and US Department of State Embassy Science Fellow. I have been a proud member of the University of Maryland faculty since Fall 2020.

I believe I have built and maintained a very strong service record over the course of my scientific career. My service activities have and currently include scientific/professional society leadership; nongovernmental organization and foundation boards and councils; journal editorships; science diplomacy with international parastatals; and trainings for practitioners in international sectors including banks, government agencies and students. I currently chair the DEIAR committee in GEOG, am the Human Subjects Protection Program Liaison, serve on the Human Dimensions Teaching Team, and have served on the Undergraduate Committee.

This is my first term serving on the Faculty Senate. I am running for a position on the Senate Executive Committee because I believe I have diverse lived experience and expertise to effectively contribute and because I strongly want to give back to the University that has provided me with a vibrant community within which to thrive as a professional and a person. I am committed to the success of the University and its community members. I have spent my entire professional life at land-grant universities and I fundamentally value and embody the mission. Previously, I was the Associate Director for Programs of the DOE Energy Frontier Research Center - Nanostructures for Electrical Energy Storage (EFRC-NEES, 2014-18), a position that brought valuable hands-on strategic planning and management experience through working with a large multi-institutional project team.

Outside the University, I am the Co-Chair of the National Organization of Research Development Professionals (NORDP) Mentoring Committee. The committee is charged with elevating research development professionals to success by offering meaningful mentoring expertise, support, training and resources, including sponsoring 1:1 mentor matching serving >150 members annually. I am also a founding member of a new Affinity Group, Immigrant Knowledge and Wisdom (iKnowW), that seeks to

empower and engage research professionals who self-identify as immigrants in inclusive excellence, resource generation, recruitment and retention of professionals in alignment with the NORDP mission.

My term as a PTK senator is ending in May and I'm interested in continuing to contribute to shared governance by serving as a non-senator on the Campus Transportation Advisory Committee (CTAC).

I have been a lecturer or senior lecturer at the UMD since 2011, and the Director of the MS Degree Program in Applied Economics since 2014. My interest in shared governance has grown, especially since my role as the director of an academic program is still student-facing, but also requires actually implementing many important UMD policies. I see directly how policies impact students and staff,

and want to bring that perspective into rooms where policy is formulated and deliberated. As a PTK faculty member working in both the 12-week, as well as the semester-based calendars, I can also bring PTK and 12-week calendar perspectives, which are still often considered only as an afterthought when important policies are formulated, despite the rapidly expanding roles of both PTK faculty, and professional academic programs that operate on the 12-week calendar.

As an outgoing senator this year, I have served as the chair of the Senate Nominations Committee, which prepares slates of candidates for 5 of the elected Senate committees and councils, including the Senate Executive Committee (SEC), CTAC, and 3 other bodies. Outside the senate I have also served on advisory committees to the BSOS dean's office on PTK matters, to the Office of Extended Studies, and the ELEVATE Program. I have participated in ADVANCE programs for professional track faculty. In 2019 I served on the planning committee for the UMD PTK Symposium. I have also been an active participant in the group of directors of professional master's degree programs in BSOS.

My interest in serving on the CTAC stems from both personal and professional interests in transportation issues on campus. The students in my program take evening classes. Many of them have spoken with me about the UMD Shuttle service upon which they rely for transportation home after their evening classes. Also, like many UMD employees, I do not come to campus 5 days a week, so I use day passes rather than semester-based parking passes. I have often wondered, for example, why the UMD parking portal does not have an app that could be used via cell phones when using the day passes. Our department has also experienced issues at times like insufficient visitor parking for our interview candidates at the Mowatt Lane garage, despite many unoccupied "U2" spots on the top floors. I have discussed things like this with the coordinator who handles parking issues for our department.

Given the 3-year term, I would focus initially on learning the ropes and developing relationships. But I would be coming to the committee with significant previous experience with campus transportation challenges, and UMD service more generally.
