MINUTES | OCTOBER 11, 2022

CALL TO ORDER

Senate Chair Newman called the meeting to order at 3:18 p.m. She explained the procedures for the meeting and provided brief instructions on using the PointSolutions platform for voting.

APPROVAL OF THE SEPTEMBER 7, 2022 SENATE MINUTES

Chair Newman asked if there were any additions or corrections to the minutes of the September 7, 2022, meeting; hearing none, she declared the minutes approved as distributed.

REPORT OF THE CHAIR

BOR Staff Awards

Chair Newman announced that the Staff Affairs Committee is currently accepting nominations for this year's Board of Regents' Staff Awards (BORSA). She reminded Senators that BORSA is the highest System-wide recognition of the exceptional work done by staff members across the University System of Maryland (USM). She explained guidelines and eligibility requirements to nominate staff members. She stated that nomination packets are due to the Staff Affairs Committee by Friday, November 11 and that detailed instructions can be found on the Senate website.

Approval of the Interim University of Maryland Non-Discrimination Policy and Procedures (Senate Document #22-23-04)

Chair Newman shared that on September 30th, President Pines approved revisions to the Interim University of Maryland Non-Discrimination Policy and Procedures (Senate Document #22-23-04). She explained that new state law changes, that were made effective on October 1, 2022, required revising definitions in the University of Maryland Non-Discrimination Policy and Procedures. The University of Maryland policy was revised to clarify current procedures related to the investigation and adjudication processes and update current University Vice President titles. She explained that a comprehensive review of the Non-Discrimination Policy and Procedure is expected to be done in the next year.

Volunteers for the Nominations Committee

Chair Newman stated that outgoing Senators would soon receive an email about volunteering for the Senate Nominations Committee.

Newman stated that every year, the Nominations Committee solicits nominations for the Senate Chair-Elect and membership on the Executive Committee, the Committee on Committees, and other University-wide committees and councils. She stated that the Senate relies on the good judgment of the members of the Nominations Committee to present candidates that reflect the quality and diversity of the campus community. Newman explained that the committee would meet between January and April.

Newman noted that those who are interested in serving on the committee should look for an email with a link to a Google form, and complete the link as soon as possible. She added that those

interested may contact the Senate Office Staff for additional information or assistance. Newman stated that the Senate will vote on the Nominations Committee's membership in December.

SPECIAL ORDER OF THE DAY

Jack Blanchard Associate Provost for Enterprise Resource Planning Elevate Project Update

Newman welcomed Jack Blanchard, Associate Provost for Enterprise Resource Planning.

Blanchard explained that Elevate's goal is to modernize the obsolete Enterprise Resource Planning (ERP) system to better meet the complex needs of the University. He elaborated further on the goals of the program to provide a positive user experience for students, staff, and faculty; to increase efficiency and effectiveness; to accurately collect, report, and analyze data; to ensure data security and privacy; and to make sure that ERP systems can be easily maintained and updated.

Blanchard presented an overview of the timeline of Workday. He provided specifics on human capital management, budgeting, and student workstream implementation over the next four years.

Blanchard shared that staff and faculty engagement is a key in ensuring that Workday will be successfully implemented. He explained that Project Implementation Teams had been implemented across the University to ensure representation. Blanchard shared that a Faculty Advisory Committee was established to ensure that the Elevate project considered the unique perspectives and needs of faculty users.

Blanchard gave an overview of the training activities timeline for Workday. He shared that Elevate is currently developing instructional and training materials. He also shared some challenges that the Elevate program will be facing in spring 2023.

Blanched passed along a note to all senators to discuss planning for the transition to Workday with their local departmental leadership. He shared that Elevate has town hall meetings every semester, the next taking place on November 2nd and 3rd. He also shared that Elevate gives monthly functional overviews, monthly newsletters, and has a website for more information.

Blanchard noted that student implementation is the highest priority, stating that students are key stakeholders. He announced that five student interns had been hired over the summer. He also announced that a lead staff position had been hired in September. He noted that student input is necessary to understand current problems.

Blanchard informed the Senate of next steps and how to stay connected and to prepare for the transition.

Newman thanked Blanchard and opened the floor for questions.

Senators were curious about what resources and processes would be put in place to manage various user experience issues post implementation.

Blanchard responded that they had received approval from leadership to develop a support organization for Workday. He shared that this organization will consist of several full-time staff to work on continually monitoring and improving unforeseen issues.

Senators suggested that Elevate also learn from the recent Concur rollout and that they take time to consult with campus constituencies before implementation.

Blanchard noted that Elevate had engaged, early in their process, with several campus constituencies for feedback.

Senators asked for a clarification of what the "cloud" is.

Blanchard explained that the cloud comes from servers that Workday is responsible for and not physical mainframes on campus.

Newman thanked Blanchard again for his presentation.

SPECIAL ORDER OF THE DAY

Will Reed

Chair of the Plan of Organization Review Committee

PORC Status Overview

Chair Newman stated that distributed in the materials was the original Plan of Organization Review Committee (PORC) charge. She informed the Senate that at the last Senate Executive Committee (SEC) meeting, the committee voted to extend the deadline of PORC until November of 2023. She added that the SEC also voted to charge PORC with conducting the review on whether or not to codify the Special Committee on University Finance (SCUF) into a formal Senate body.

Chair Newman stated that given these recent changes, the Chair of PORC, Will Reed, would be giving Senators a brief update on the status of PORC.

Chair Newman welcomed Will Reed and invited him to provide his presentation.

Reed thanked Chair Newman and provided a brief history and overview of PORC. He gave Senators an overview of how often PORC convenes, the issues that PORC generally is charged to review, and why PORC has been convened earlier than its usual timeline. He listed the members on the committee, noting in particular the diversity of constituencies represented by the committee.

Reed gave an overview and history of the areas that PORC had been charged with reviewing, which included the current Plan of Organization, revisions to the Plan of Organization, apportionment, councils, and principles surrounding shared governance. He gave an overview and content of PORC meetings that occurred during the spring of 2022 and that three subcommittees were formed to discuss the issues of apportionment, councils, and shared governance which met throughout the summer.

Reed shared that due to recent transitions in the Senate office that work has been currently put on hold. He informed Senators of next steps and the updated timelines of PORC.

Senators asked if at any time during PORC's review if they were going to survey or solicit Senate members on any of their ideas.

Reed stated that there had not been any plans made yet to solicit Senators. He explained the logic behind the composition of the committee but that he is not opposed to the idea and that guidance from Senate leadership would have to be sought to see if this was feasible.

Newman thanked Reed again for his presentation.

NEW BUSINESS

Chair Newman asked Senators if there was any new business.

Senator Blackwell, Exempt Staff, Office of Community Engagement shared the Office of Community Engagement paired with the city of College Park to host the 11th annual Good Neighbor Day. She invited all to join on November 12th from 8:30a.m.-12:00p.m. More information can be found at oce.umd.edu.

Senator Lekic, TTK Faculty, College of Computer, Mathematical, and Natural Sciences shared a concern about Concur and asked what the Senate's role is when implementing administrative procedures.

Newman thanked Senator Lekic for the comment and stated that a Concur presentation would happen at the November 2, 2022 Senate meeting. She shared that the Senate does not have a role in implementing administrative procedures that are not policies.

Senator Ram-Andriessens, Exempt Staff, University Human Resources invited all to the USM wide professional development conference from October 17-22, 2022. The conference will offer tracks of personal development; professional development; diversity, equity, and inclusion; leadership; and wellness. She went on to say that the professional development was open to staff, faculty, graduate and undergraduate students. ISSUE

The College of Education's Department of Human Development and Quantitative Methodology proposes to change the name of its Certificate of Advanced Study in "Measurement, Statistics and Evaluation" to "Quantitative Methodology: Measurement and Statistics". After determining that the current name no longer accurately reflects the full scope of the program's activities, the faculty voted unanimously to change the program's name. Incorporating "Quantitative Methodology" into the program title reflects the broader applications of the skills and knowledge students gain from the program, whereas retaining "Measurement and Statistics" in the title links the program to its past identity as a program that applies methods research to educational problems. The program faculty have detected some confusion in the past several years as different constituents refer to the program in different ways, some referring to it by its technical name of "Measurement, Statistics, and Evaluation," or its traditional acronym EDMS, and some referring to it as "Quantitative Methodology," because of its alignment with the name of the department. The new title, "Quantitative Methodology: Measurement and Statistics," will rebrand the program under one title that reflects its traditional, current, and future activities. Separate proposals have been submitted in order to rename all of the graduate programs in "Measurement, Statistics, and Evaluation" to "Quantitative Methodology: Measurement and Statistics".

The proposal was approved by the Graduate School PCC committee on September 29, 2022, and the Senate Programs, Curricula, and Courses committee on October 7, 2022.

RECOMMENDATION(S)

The Senate Committee on Programs, Curricula, and Courses recommends that the Senate approve this name change.

COMMITTEE WORK

The committee considered this proposal at its meeting on October 7, 2022. Ji Seung Yang, from the Department of Human Development and Quantitative Methodology, presented the proposal and answered questions from the committee. The committee approved the proposal.

ALTERNATIVES

The Senate could decline to approve this new program title.

RISKS

If the Senate declines to approve this program title change, the current program will not adequately describe the coursework and activities of the program.

FINANCIAL IMPLICATIONS

There are no significant financial implications for program title changes.

Proposal Summary

The program formally known as Measurement, Statistics and Evaluation (EDMS) in the Department of Human Development and Quantitative Methodology (HDQM) in the College of Education is proposing to change its program's name to Quantitative Methodology. Measurement and Statistics (QMMS).

Program and Catalog Information

Catalog Program Requirements:

The Certificate in Measurement, Statistics and Evaluation (https://academiccatalog.umd.edu/graduate/programs/measurement-statistics-evaluation-z019/) is designed to provide advanced training in quantitative methods for graduate students majoring in other doctoral programs. The certificate requires a minimum of 21 graduate credit hours. In addition, an advisor must be selected from members of the Measurement, Statistics and Evaluation faculty.

Program Modification Information

Impact on current students. It should be specifically acknowledged that students enrolled in the program prior to the effective date of any curriculum change may complete their program under the old requirements if they wish. The courses required must remain available, or suitable substitutions specifically designated.

The impact on current students will be minimal. Any certificate student who entered the certificate program under the name Measurement, Statistics and Evaluation (EDMS) will have the choice to keep this name on their diploma. However, all certificate students who enter the program after the effective start date of the new program name (we hope in Fall 2022) will have the new program, Quantitative Methodology: Measurement and Statistics (QMMS), name on their diploma.

Currently, this certificate program is inactive but we wanted it included under the umbrella of the program's new name.

Renaming Program

Provide a rationale for renaming the program.

EDMS Program Name Change

Over the past 2 years, the Measurement, Statistics and Evaluation (EDMS) Program faculty have been discussing changing our name. A small subcommittee was formed to gather information about what different names—and acronyms—we seem to have across the department, college and campus; and subsequently, what name would the current faculty like to adopt officially.

At our February 7, 2022 program faculty meeting the EDMS faculty unanimously voted to change our name (and 4-letter acronym) from Measurement, Statistics and Evaluation (EDMS) to Quantitative Methodology: Measurement and Statistics (or QMMS). This was done for two main reasons.

- 1. In an effort to remain current with quantitative methods broadly construed in our profession, our program faculty thought that Measurement, Statistics and Evaluation no longer adequately captured the research areas and focus of our faculty. Nor did it satisfactorily capture where we see quantitative methods research going in the next 5-10 years and beyond. After serious debate and deliberation about this type of "re-branding," we felt that the Quantitative Methodology (part of our new proposed name) aligned with the Departmental naming convention and the "Measurement and Statistics" structure links to our past identity. Although housed in a college of education where applications of our methods research to educational problems is important, we also take note that our methods are being employed in the broader behavioral science and social science communities—as well as in the health sciences.
- 2. Secondly, I am not certain if you have noticed, but we seem to have an identity crisis of sorts. If you look across campus at different pertinent websites (i.e., Graduate Catalog, HDQM website), you might have noticed that we have been referred to as (1) QM (Quantitative Methodology), (2) MSE (Measurement, Statistics and Evaluation), and (3) EDMS (the 4-letter naming convention on Testudo). We did not make these acronyms up but

nevertheless they have materialized and followed us. So, part of this renaming effort is to bring clarity to a unified acronym (QMMS), which the current program faculty is solidly behind.

We have reached out to targeted area alums of our program to gauge their reaction to a name change. Their reactions and responses were initially mixed—citing an affinity and affection to the EDMS acronym. But after stating our reasoning behind making this change, all we spoke to were supportive.

HDQM's Plan of Organization requires programmatic changes of this magnitude to have the endorsement of the (1) Executive Committee (which endorsed this renaming effort in an earlier meeting this month), (2) the HD faculty, and (3) the HDQM Graduate Education Committee.

EDMS Program Name Change

Over the past 2 years, the Measurement, Statistics and Evaluation (EDMS) Program faculty have been discussing changing our name. A small subcommittee was formed to gather information about what different names—and acronyms—we seem to have across the department, college and campus; and subsequently, what name would the current faculty like to adopt officially. At our February 7, 2022 program faculty meeting the EDMS faculty unanimously voted to change our name (and 4-letter acronym) from Measurement, Statistics and Evaluation (EDMS) to Quantitative Methodology: Measurement and Statistics (or QMMS). This was done for two main reasons.

- 1. In an effort to remain current with quantitative methods broadly construed in our profession, our program faculty thought that Measurement, Statistics and Evaluation no longer adequately captured the research areas and focus of our faculty. Nor did it satisfactorily capture where we see quantitative methods research going in the next 5-10 years and beyond. After serious debate and deliberation about this type of "re-branding," we felt that the Quantitative Methodology (part of our new proposed name) aligned with the Departmental naming convention and the "Measurement and Statistics" structure links to our past identity. Although housed in a college of education where applications of our methods research to educational problems is important, we also take note that our methods are being employed in the broader behavioral science and social science communities—as well as in the health sciences.
- 2. Secondly, I am not certain if you have noticed, but we seem to have an identity crisis of sorts. If you look across campus at different pertinent websites (i.e., Graduate Catalog, HDQM website), you might have noticed that we have been referred to as (1) QM (Quantitative Methodology), (2) MSE (Measurement, Statistics and Evaluation), and (3) EDMS (the 4-letter naming convention on Testudo). We did not make these acronyms up but nevertheless they have materialized and followed us. So, part of this renaming effort is to bring clarity to a unified acronym (QMMS), which the current program faculty is solidly behind.

We have reached out to targeted area alums of our program to gauge their reaction to a name change. Their reactions and responses were initially mixed—citing an affinity and affection to the EDMS acronym. But after stating our reasoning behind making this change, all we spoke to were supportive.

HDQM's Plan of Organization requires programmatic changes of this magnitude to have the endorsement of the (1) Executive Committee (which endorsed this renaming effort in an earlier meeting this month), (2) the HD faculty, and (3) the HDQM Graduate Education Committee.

ISSUE

The College of Education's Department of Human Development and Quantitative Methodology proposes to change the name of its Master of Science in "Measurement, Statistics and Evaluation" to "Quantitative Methodology: Measurement and Statistics". After determining that the current name no longer accurately reflects the full scope of the program's activities, the faculty voted unanimously to change the program's name. Incorporating "Quantitative Methodology" into the program title reflects the broader applications of the skills and knowledge students gain from the program, whereas retaining "Measurement and Statistics" in the title links the program to its past identity as a program that applies methods research to educational problems. The program faculty have detected some confusion in the past several years as different constituents refer to the program in different ways, some referring to it by its technical name of "Measurement, Statistics, and Evaluation," or its traditional acronym EDMS, and some referring to it as "Quantitative" Methodology," because of its alignment with the name of the department. The new title, "Quantitative Methodology: Measurement and Statistics," will rebrand the program under one title that reflects its traditional, current, and future activities. Separate proposals have been submitted in order to rename all of the graduate programs in "Measurement, Statistics, and Evaluation" to "Quantitative Methodology: Measurement and Statistics".

The proposal was approved by the Graduate School PCC committee on September 29, 2022, and the Senate Programs, Curricula, and Courses committee on October 7, 2022.

RECOMMENDATION(S)

The Senate Committee on Programs, Curricula, and Courses recommends that the Senate approve this name change.

COMMITTEE WORK

The program requires a minimum of 30 credit hours in courses acceptable for credit toward a graduate degree. At least 18 must be selected from courses numbered 600 or above, combining content from statistics, measurement, evaluation, and related fields outside of the Department (a maximum of 6 outside hours).

Courses within the program are selected from offerings of Measurement, Statistics and Evaluation program and other departments of the University. A program for a student will be structured to take into account the background and future aims of the individual. There is a common core of courses comprised of:

EDMS Program Name Change

Over the past 2 years, the Measurement, Statistics and Evaluation (EDMS) Program faculty have been discussing changing our name. A small subcommittee was formed to gather information about what different names—and acronyms—we seem to have across the department, college and campus; and subsequently, what name would the current faculty like to adopt officially. At our February 7, 2022 program faculty meeting the EDMS faculty unanimously voted to change our name (and 4-letter acronym) from Measurement, Statistics and Evaluation (EDMS) to Quantitative Methodology: Measurement and Statistics (or QMMS). This was done for two main reasons.

- 1. In an effort to remain current with quantitative methods broadly construed in our profession, our program faculty thought that Measurement, Statistics and Evaluation no longer adequately captured the research areas and focus of our faculty. Nor did it satisfactorily capture where we see quantitative methods research going in the next 5-10 years and beyond. After serious debate and deliberation about this type of "re-branding," we felt that the Quantitative Methodology (part of our new proposed name) aligned with the Departmental naming convention and the "Measurement and Statistics" structure links to our past identity. Although housed in a college of education where applications of our methods research to educational problems is important, we also take note that our methods are being employed in the broader behavioral science and social science communities—as well as in the health sciences.
- 2. Secondly, I am not certain if you have noticed, but we seem to have an identity crisis of sorts. If you look across campus at different pertinent websites (i.e., Graduate Catalog, HDQM website), you might have noticed that we have been referred to as (1) QM (Quantitative Methodology), (2) MSE (Measurement, Statistics and Evaluation), and (3) EDMS (the 4-letter naming convention on Testudo). We did not make these acronyms up but nevertheless they have materialized and followed us. So, part of this renaming effort is to bring clarity to a unified acronym (QMMS), which the current program faculty is solidly behind.

We have reached out to targeted area alums of our program to gauge their reaction to a name change. Their reactions and responses were initially mixed—citing an affinity and affection to the EDMS acronym. But after stating our reasoning behind making this change, all we spoke to were supportive.

HDQM's Plan of Organization requires programmatic changes of this magnitude to have the endorsement of the (1) Executive Committee (which endorsed this renaming effort in an earlier meeting this month), (2) the HD faculty, and (3) the HDQM Graduate Education Committee.

After determining that the current name no longer accurately reflects the full scope of the program's activities, the faculty voted unanimously to change the program's name. Incorporating "Quantitative Methodology" into the program title reflects the broader applications of the skills and knowledge students gain from the program, whereas retaining "Measurement and Statistics" in the title links the program to its past identity as a program that applies methods research to educational problems. The program faculty have detected some confusion in the past several years as different constituents refer to the program in different ways, some referring to it by its technical name of "Measurement, Statistics, and Evaluation," or its traditional acronym EDMS, and some referring to it as "Quantitative" Methodology," because of its alignment with the name of the department. ISSUE

The College of Education's Department of Human Development and Quantitative Methodology proposes to change the name of its Master of Education in "Measurement, Statistics and Evaluation" to "Quantitative Methodology: Measurement and Statistics". After determining that the current name no longer accurately reflects the full scope of the program's activities, the faculty voted unanimously to change the program's name. Incorporating "Quantitative Methodology" into the program title reflects the broader applications of the skills and knowledge students gain from the program, whereas retaining "Measurement and Statistics" in the title links the program to its past identity as a program that applies methods research to educational problems. The program faculty have detected some confusion in the past several years as different constituents refer to the program in different ways, some referring to it by its technical name of "Measurement, Statistics, and Evaluation," or its traditional acronym EDMS, and some referring to it as "Quantitative Methodology," because of its alignment with the name of the department. The new title, "Quantitative Methodology: Measurement and Statistics," will rebrand the program under one title that reflects its traditional, current, and future activities. Separate proposals have been submitted in order to rename all of the graduate programs in "Measurement, Statistics, and Evaluation" to "Quantitative Methodology: Measurement and Statistics".

The proposal was approved by the Graduate School PCC committee on September 29, 2022, and the Senate Programs, Curricula, and Courses committee on October 7, 2022.

At our February 7, 2022 program faculty meeting the EDMS faculty unanimously voted to change our name (and 4-letter acronym) from Measurement, Statistics and Evaluation (EDMS) to Quantitative Methodology: Measurement and Statistics (or QMMS). This was done for two main reasons.

In an effort to remain current with quantitative methods broadly construed in our profession, our program faculty thought that Measurement, Statistics and Evaluation no longer adequately captured the research areas and focus of our faculty. Nor did it satisfactorily capture where we see quantitative methods research going in the next 5-10 years and beyond. After serious debate and deliberation about this type of "re-branding," we felt that the Quantitative Methodology (part of our new proposed name) aligned with the Departmental naming convention and the "Measurement and Statistics" structure links to our past identity. Although housed in a college of education where applications of our methods research to educational problems is important, we also take note that our methods are being employed in the broader behavioral science and social science communities—as well as in the health sciences.
- 2. Secondly, I am not certain if you have noticed, but we seem to have an identity crisis of sorts. If you look across campus at different pertinent websites (i.e., Graduate Catalog, HDQM website), you might have noticed that we have been referred to as (1) QM (Quantitative Methodology), (2)

The A. James Clark School of Engineering's Department of Electrical and Computer Engineering proposes to change the name of its Bachelor of Science in "Embedded Systems and Internet of Things" to "Cyber-Physical Systems Engineering". The program, which was established in 2019 and is offered at the Universities at Shady Grove, provides students with an understanding of both the hardware and software elements that go into design, development, and use of devices that link to the internet or other communication networks. The need to change the name has arisen from a requirement from the engineering accreditation agency, ABET, to include the word "engineering," in all engineering program titles. The department is also using this occasion to change the name to a less verbose name that better conveys the broad nature of this program of study.

The proposal was approved by the Senate Programs, Curricula, and Courses committee on October 7, 2022.

RECOMMENDATION(S)
