ISSUE

Candidacy Statements for the Chair-Elect 2018-2019 Election

Chair-Elect Nominees

Kim Coles, Associate Professor, Department of English, College of Arts & Humanities

I am honored to have been asked to stand for the position of Chair-Elect of the Senate Executive Committee. I have been at the University of Maryland for 13 years, and am currently completing my first year as a Campus Senator and a member of the Senate Executive Committee.

I organized and executed a campus-wide initiative, “Democracy Then and Now: Citizenship and Public Education,” in the fall of 2016. The experience connected me to various departments and administrative offices across campus. I am now very familiar with the workings of the university campus and the various administrative offices of the ARHU Dean, Dean of Undergraduate Studies, the Office of the Provost and of the President. “Democracy Then and Now” was a campus-wide initiative exploring the central role of public education in the development of American democracy (<http://dtn.umd.edu>). DTN asked students, faculty, and staff to consider what good public education means now in terms of civic participation, political representation, and full citizenship rights for all people in this country. It captured ten different departments in its programming, involved various colleges, departments, and centers, and brought writers and speakers to campus, such as MacArthur Fellow (2016) and poet, Claudia Rankine (author of *Citizen: An American Lyric*). The organization of this cross-campus initiative gave me insight into how campus cooperation can be introduced and enhanced. It allowed me to see how various bodies within the university are run, and enabled me to understand the various commitments that animate individual departments and colleges. This perspective will serve me well as the Chair-Elect of a committee that engages in oversight of the university campus.

With respect to my colleagues in the sciences—and respect is due—I think it is time for a member of the Humanities faculty to serve (eventually) as Chair of the SEC. This is not only to have representation from different areas of the campus, which is itself extremely important; it is also to have the benefit of different skills and competencies. I teach early modern English literature, in Gen Ed as well as advanced courses in our department. As a discipline, English stresses analysis and argument: students read the codes of complicated texts and reassemble them in the structure of their own arguments. If a life-long love of Milton or Spenser is not the real objective of an English course, making the students better able to read the world around them and empowering them to express their ideas certainly is. Due to the method of such instruction, I spend a lot of my time talking to students: I spend a lot of time listening to them, but I also spend a lot of time putting complex ideas in the simplest terms possible. Both skills strike me as applicable to the role of SEC Chair. In my various administrative roles in my department, a great deal of my time and effort is involved in internal evaluation, learning-outcomes assessment, and the advising and mentoring of students. This marks a conviction on the part of my department that the improvement of student experience comes through constant self-assessment and course correction. This seems a good model for other modes of campus governance and campus life.

The experience of serving on the Senate Executive Committee, the interaction with the other committee members, the campus administrators, the Provost and the President, has allowed me to forge the relationships requisite to the position of Chair-Elect. I have tried to be an active listener in our meetings, and to be engaged as much in questions as in answers. Working to be more inclusive of various opinions around the table, from various perspectives around the campus, and to build consensus from these points of view, has been the particular skill set that I have tried to cultivate. As Chair-Elect, I will prepare for the role of Chair of the Senate Executive Committee; I hope to foster consensus within it, and promote campus cooperation outside of it, in order to complete the important work that is in front of us.

Pamela Lanford, Director of Animal Research Support & IACUC Administrator, Office of Research Compliance, Division of Research

I am pleased and honored to be nominated for the position of Chair of the UMD University Senate. UMD is an important part of my life - I have been affiliated with the University for nearly 27 years, first as a graduate student and later as a faculty member. Being the PTK Senator representative from the Division of Research,

and serving on the Senate Executive Committee, the Committee on Committees, and ad hoc Senate committees has only deepened my connection to our institution, and I would be thrilled with the opportunity to learn about and contribute more to our community.

I am first and foremost a scientist and an educator, and spent many years teaching and managing undergraduate lab courses in the biological sciences. I have been a faculty representative to the Office of Student Conduct, have worked on multiple curriculum initiatives in the Life Sciences, and participated in the Learning Outcomes Assessment for Life Sciences CORE faculty committee.

In more recent years I have served the University in an administrative capacity, first as program coordinator for the ADVANCE Program for Inclusive Excellence, and currently as Administrator and Vice Chair of the Institutional Animal Care and Use Committee (IACUC). With ADVANCE I served on the President's Commission on Women's Issues, became a member of the Rainbow Terrapin Network, and oversaw the ADVANCE Interdisciplinary Seed Grant awards process, which put me in touch with faculty and administrators from all parts of campus. In my current position as IACUC Administrator, I regularly interact with faculty, post-docs and students, and sit on the Institutional Biosafety Committee, the Facilities Advisory Committee, and the Research Support Oversight Committee.

The variety of ways that I have worked and served within the University have provided me with a greater global context and understanding of how the university works, but I would look forward to expanding my knowledge and my contributions. My time as Senator has been very rewarding, and I would be thrilled and deeply honored to serve as Chair of the University Senate.

Cynthia Frank, Librarian II, University Libraries

I spent this past year on the Senate Executive Committee, and I would like to serve again on the SEC, as I am motivated to guide our University into a strong future.

I have worked on this campus for 25 years, first in a staff position and now as a Library faculty member. I am embedded in the School of Architecture, Planning and Preservation, and I run the Architecture Library. I work with both undergraduate and graduate students, and my work colleagues are in the libraries and the School of Architecture, Planning and Preservation. As a university employee, a faculty member, an alumna and a parent of a Maryland graduate, I believe I bring a range of perspectives to the table when the SEC considers the various issues before us. I also see around us the stressors of a current political climate and social issues that will continue to affect our students lives dramatically in the near future, and we as a University will need to keep up, and support our campus community.

Jason Kahn, Associate Professor, Chemistry & Biochemistry, College of Computer, Mathematical, & Natural Sciences

It is an honor to be considered for the Senate Executive Committee, and I look forward to serving the University as we adjust to changes in the student population, the composition of the faculty, and the changing landscape of education worldwide.

I have been at UMD since 1994 and am now an Associate Professor in the Dept. of Chemistry and Biochemistry. I view research, teaching, and service as melding into one other, not being distinct activities. Besides my own research on DNA and protein-nucleic acid interaction, I mentored a Gemstone team of 14 undergraduates, and for the last four years I have co-mentored the UMaryland iGEM (international genetically engineered machines) team. I have served on a variety of curriculum committees. As an Elevate Fellow at the TLTC, I focused on deploying simulation programs, some derived from my research, that foster active learning. I have taught courses ranging from freshman chemistry for engineers to graduate seminars in regulatory networks to an Honors seminar on nanotechnology in science, business, and fiction. I chair the campus Laboratory Operations and Safety Committee and serve on the Research Support Oversight Committee. This is my second term in the Senate, and I have served on a faculty grievance hearing board. Outside the University, I am on the editorial board of the Biophysical Journal and a judge for the Regeneron (formerly Intel) Science Talent Search.

The Senate runs much more efficiently and takes on more challenging issues now than it did in my first term (2009-2012). This trend must continue as the university strives to bring in more students with diverse backgrounds and needs and then educate them to succeed in an uncertain, interconnected, fragile world. We should take a holistic look at all aspects of the undergraduate experience, from admissions through to career placement. We must train graduate students for long-term success. We should listen more to staff and PTK faculty and give them more time for personal development. We should demand more engagement from TT faculty by providing opportunities for interactions outside their own research and scholarship and also by providing more help in balancing the increasing demands on their time. The Senate is uniquely suitable for synthesizing the views of all these constituencies. We should encourage the administration to engage with us more consistently so that the University can make better use of the wisdom of this body.

Pamela Lanford, Director of Animal Research Support & IACUC Administrator, Office of Research Compliance, Division of Research

I am very pleased and honored to be nominated to sit on the Senate Executive Committee for a second term. I have greatly enjoyed the past year's work on the SEC, and look forward to continuing my contribution to the Senate and the campus as a whole. Marc Pound, Senior Research Scientist, Astronomy, College of Computer, Mathematical, & Natural Sciences

I seek re-election to the SEC for a third and final term.

My connection with the University goes back more than 20 years. I received my Ph.D. here in 1994, and joined the faculty as a postdoc in 1997. At that time, campus governance was the furthest thing from my mind. But, in the intervening years, I have come to appreciate the unique model of shared governance here, and its power to cultivate fairness to and respect for the many diverse voices we have in our campus community.

I have been deeply involved in Professional Track (PTK) faculty issues for the last 9 years. I was elected to the University Senate in 2009 as the sole Senator representing over 1600 Research faculty and served 2 terms. During this time, I began advocating for increased representation of what was then called non-tenure track faculty in my capacity both as a Senator and as a member and later Chair of the Elections, Representation, and Governance (ERG) Committee. We have come a long way since then, with PTK faculty now fully apportioned in the University Senate, and a broad range of issues affecting PTK academic lives are being addressed.

Because of my experience, advocacy, and dedication, I am actively sought to serve on many University committees, especially those related to faculty affairs. I am currently a member of SEC, a CMNS College Councillor, an ADVANCE Terp Ally, and finishing up another two-year term as Chair of ERG. I previously served on the Provost-Senate Task Force on Non-Tenure Track Faculty, on the Middle States Accreditation Committee, on the Faculty Affairs Committee, and chaired the FAC subcommittee that reviewed all College PTK appointment & promotion plans. While serving on these committees, I have seen up close the complex interweave of academic freedom, excellence in education for our students, workplace satisfaction, and effective and efficient administration, that makes up the fabric of our university.

I believe in service; I believe in shared governance; I believe in advocating for beneficial change; I believe in rolling up one's sleeves and getting the job done. As a member of the SEC, I will continue to collaboratively work with the broad array of campus stakeholders to achieve positive changes in our community, while ensuring the perspectives of PTK faculty are considered.

Edward Priola, Senior Lecturer, Institute of Applied Agriculture, College of Agriculture & Natural Resources

The UMD Senate needs strong representation for Professional Track Faculty (PTK). My credentials fit the bill. After working in the private sector for a couple of decades, I joined UMD in 2012 as an Oral Communication Lecturer. Since then, I earned a Doctor of Management degree and was promoted to Senior Lecturer. I bring fresh perspectives informed by years of working as a USAID contractor to develop civil society in Afghanistan, Albania, and Romania. These experiences gave me a deep sensitivity for working in multicultural organizations.

I have served as a UMD Senator for two years now. My policy interests center on: (a) the challenges of

safeguarding free-speech and academic freedom while powerfully confronting hateful behavior, and (b) promoting the professional advancement of UMD's PTK community.

William Robin, Assistant Professor, School of Music, College of Arts & Humanities

I am excited for the opportunity to serve on the Senate Executive Committee. I am finishing my second year as an assistant professor of musicology at UMD, and though this will be my first term on the Senate, I have already served on several School of Music committees and have significant committee experience from my graduate studies at UNC Chapel Hill. Having recently arrived at Maryland, I am enthusiastic to bring a fresh perspective to how the university operates. I am eager to contribute a strong faculty perspective to the major issues that have been shaping our campus and, having recently completed my PhD, I also seek to amplify the voices of students. Neil Sehgal, Assistant Professor, Health Services Administration, School of Public Health

Though I am new to the University Senate, the arena of campus committee service is well familiar to me, and I have embraced opportunities for service at every stage of my academic career. The opportunity to participate in shared governance was for me, as I'm sure for many of you, a key reason for my pursuit of a career in the academy, and a responsibility I don't take lightly. Parallel to my commitment to campus service is my commitment to public higher education – I feel a responsibility to leverage the power of the University to change society, and in my mind there is no more democratic place to push for that than a campus such as ours.

A key motivation for my campus service has been to build community among faculty across disciplines, with students, and the community at large. In my two years at UMD I have embraced opportunities for service to SPH and the University. This year I helped launch the Robert and Barbara Gold Public Health Innovation Award, a competition which was successful both in catalyzing a culture of innovation at SPH and in elevating the ideas of our students (with both Gold Awardees working on bringing their innovations to market). Additionally, I serve as the faculty representative to the SPH Alumni Association, helping link our academic programs with the School's alumni. Within my department I serve as the co-faculty advisor for the Health Services Administration Student Association and the advisor to the Health Services Administration case competition teams, coaching student teams competing in the Washington Metropolitan Area Chapter of the National Association of Health Services Executives Health Innovation Competition and the National Association of Health Services Executives Everett V. Fox Student Case Competition, dedicating time and energy to foster a positive environment for HLSA students outside of the classroom. Finally, I have served enthusiastically on the Diversity Committee, as a volunteer for the Mid-Maryland Mission of Mercy and Health Equity Festival, and is helping develop a cloud research computing environment for SPH faculty.

In addition to my service within the School, I have been an ambassador for SPH on campus serving on the Future of Information Alliance Brainstorming Board, and representing the School of Public Health on the UMD Banneker/Key Scholarship selection committee and the Research Technologies Working Group.

I hope that my experiences and perspective will be helpful to my service as a University Senator, and I would be honored to devote them and my diligence as a member of the Senate Executive Committee.

Dylan Selterman, Lecturer, Psychology, College of Behavioral & Social Sciences

I am very excited to be considered for a position on the University Senate Executive Committee. I am completing my 7th year working as a Lecturer in the Psychology Department (BSOS). Aside from teaching and a modest research program, I engage in meaningful service to the university community and to my field. Faculty Nominees

Amelia Arria, Associate Professor & Director, Behavioral & Community Health, School of Public Health

I would be honored to serve on the University Athletic Council. I believe I can bring a fresh perspective to the important work of the Council and I am deeply committed to maximizing the potential of our student athletes. For almost twenty years, I have been actively engaged in research on the behavioral health of college students. I have been a member of the University community as a research faculty member since 1999, and in 2013 received a tenured position in my current department. During my academic career, I have had the privilege of serving the University in many ways—as the Chair of the Faculty Senate of the School of Public Health since 2015 and most recently as a member of the President’s Sexual Assault Prevention Task Force. I am also the PI on a policy initiative funded by the Maryland Department of Health to provide technical assistance and training to fifteen universities across Maryland. This work helps to ensure that the policies and strategies college implement with respect to excessive drinking are rooted in the best scientific evidence possible. Oscar Barbarin, Professor & Chair, African American Studies, College of Behavioral & Social Sciences

This year I was honored to have been elected to and serve on the Senate executive committee. Much has happened during my brief tenure that has shaped my views of the University and the challenges we face in carrying out our mission. Like many at UMD I was very moved by the violent death of Lieut. Collins on our campus and all the issues that surfaced for students and faculty in the aftermath. I have been involved in the University’s committee to examine issues of diversity, free speech and inclusion. In the process I have also become aware of the difficult and complex challenges the University faces. A well-run athletic program can bring positive visibility to the university by demonstrating our values of excellence and integrity. Of course all large programs have to deal with challenges in finances and ensuring that student-athletes are able to realize their goals both on the field and in the classroom. Our recent move to the Big 10 has raised the visibility of our athletic programs and has a potential to improve their financial prospects. The challenge going forward will be ensure that these increased competitive pressures can be met without imperiling the integrity of our programs. The role of the Athletic Council is to provide oversight and guidance to the programs to ensure that they are run in a financially sustainable manner and that the student-athletes leave UMD prepared for success.
