

#### NOTES FROM THE SENATE MEETING

At the <u>December 4, 2018, Senate Meeting</u>, President Loh gave his State of the Campus Address. He praised the University's system of shared governance and noted that it is a unique form of academic democracy. President Loh reported on the University's major accomplishments during his tenure and provided an update on future projects, including plans for building new dorms and redevelopment efforts in the City of College Park.

Chair Walsh noted that elections for staff, student, and single-member constituency Senators for 2019–2020 will begin on <u>January 22, 2019</u>. He also reported that the Chancellor and the Board of Regents had acknowledged receipt of the Senate's <u>Resolution Condemning the Actions of the Board of Regents</u>.

The Senate voted to approve the <u>UMD Policies and Procedures on the</u> <u>Disclosure of Student Academic Records (Senate Document #17–18–16).</u>

The Student Conduct Committee presented proposed revisions to the <u>Code of Academic Integrity (Senate Document #17–18–08)</u>. Senators discussed and voted to approve the revised policy after amending the definition of self–plagiarism.

Proposals to establish a <u>Bachelor of Science in Embedded Systems and the</u> Internet of Things (Senate Document #18–19–19) and a <u>Bachelor of Arts in University President.</u>

Philosophy, Politics, and Economics (Senate Document #18–19–20) were also approved by the Senate.

The Senate debates and votes on policy-related issues and other governing aspects of the University. The Senate directly advises the University President.





Your added time and attendance allowed us to approve two new programs, have a meaningful discussion on the concept of "self-plagiarism," and also pass the Revision of the Code of Academic Integrity (Senate Document #17–18–08). Completing these items at our December meeting helped us meet higher level deadlines with the Maryland Higher Education Commission (MHEC), and ensure that the necessary revisions to the University policies on student records and academic integrity will be in place for the upcoming semester.

### Committee News



The Senate's ten standing committees continue to make progress on all the charges they have received this fall. The APAS Committee is continuing its review of a charge involving course evaluations. The Elections, Representation, and Governance Committee continues to review a proposal on Enhancing Senate Input on University Planning and Resources, as well as finishing Revisions to the University of Maryland Libraries Plan of Organization. The EDI Committee continues to review the Non-Discrimination Policy.

#### Senate Elections

The University Senate Office holds elections through the Senate website each year to fill staff, student, and single-member constituency vacancies on the Senate. New staff Senators will serve a three-year term, and student Senators and Senators representing single-member constituencies will serve a one-year term. Senators representing full-time tenured/ tenure-track (T/TT) faculty and professional track (PTK) faculty are elected by each College or School and serve three-year terms.

Staff members will elect new Senators to replace those with terms ending this year in the categories of exempt and non-exempt staff from Divisions and exempt and non-exempt staff from the Colleges and Schools. Undergraduate students will elect representatives by College, based on their primary major. Graduate students will elect 10 representatives at-large. Student Senators can serve a total of 3 consecutive one-year terms.

Representatives of the single-member constituencies listed below are each elected for a one-year term from among their ranks and are eligible to be elected for 3 consecutive terms:

- part-time research, part-time teaching, adjunct, and all visiting faculty
- emeriti faculty
- head coaches
- post-doctoral scholars, post-doctoral associates, junior lecturers, and faculty assistants
- contingent II staff
- part-time undergraduate students
- part-time graduate students

The Senate elections are your opportunity to choose who you want to represent you on the largest governing body at the University of Maryland. Eligible campus community members will receive information via email on the sign-up and elections processes. We invite you to run for the Senate and vote in the Senate elections!
