

NOTES FROM THE SENATE MEETING

At the November 7, 2018, Senate meeting, Chair Walsh reviewed the events of the November 2, 2018, Emergency Special Senate Meeting and announced that the Senate Resolution Condemning the Actions of the Board of Regents had been passed and is now public. He also reminded the Senate that the Staff Affairs Committee is accepting nominations for the Board of Regents' Staff Awards until November 16, 2018.

Senators continued discussion from the previous Emergency Special Meeting regarding the Resolution to Improve the Status of Shared Governance in the University System of Maryland (Senate Document #18–19–17). The Senate was unable to complete its discussion and vote on this action item. The resolution will be further discussed at the Senate's second <u>Special Senate Meeting</u> on Wednesday, November 14, 2018.

Due to the lively debate and amendments to the resolution proposed by Senators at the meeting, the other agenda items have been carried over to the November 14 Special Senate meeting.

From the Senate Chair

The past month has seen a whirlwind of activity on campus and at the Senate. During that time, the report concerning Jordan McNair's death was released. This was soon followed by the report on the football team's culture. These precipitated a series of meetings by the Board of Regents, the reinstatement of Coach Durkin, and the announcement of President Loh's retirement.

Dr. Lanford, University Senate Chair-Elect, and an SEC subcommittee reviewed both reports. As things were moving rapidly and the Board's decisions were viewed unfavorably, we felt it necessary to call an Emergency Special Senate Meeting on Friday, November 2, 2018. That meeting allowed the Senate to discuss these matters in detail and find consensus. At the Special Meeting, we heard from Dr. Lanford, who summarized the subcommittee's work, and Athletic Council Chair Nick Hadley



outlined the Athletic Council's membership and its recent deliberations. Following these reports, the Senate approved a resolution condemning the Board of Regents for actions that overstepped its role in shared governance.

The Senate leadership was guided in this crisis by lessons learned at the Big Ten Academic Alliance's annual meeting of campus leaders (BTAA). The leadership meeting was held at the University of Iowa just prior to the Maryland Board of Regents' actions. At the BTAA conference, we discussed key issues faced by other Big Ten Universities.

As we have discussed and debated these important matters, we have not been able to address our regular Senate business in a timely manner. To remedy this, we've called a second Special Meeting for Wednesday, November 14, 2018, at 2 PM. This second Special Meeting is needed to complete our discussion of the upcoming search for a new

President, Senate PCC proposals, and discussions by invited speakers who could not present at our regularly scheduled November meeting. Since President Loh's State of the Campus will be the main order of business at the December meeting, a second Special Senate Meeting is greatly needed.
